We are making every effort to maintain a safe level of care for all our residents. We have block booked agency nurses and Health care assistants through several agencies up to mid –may and so far we have managed to maintain staffing levels but with an altered skill mix. [REDACTED] or myself are on site 7/7 and 4 senior Clinical nurses work on a rotational basis to provide support ,advice and practical assistance to staff at ward level. 5 student nurses have commenced working here as HCAs and are inducted and supported by the CNS in Gerontology. 2 staff nurses commenced here this week and ADON in practice development commenced their induction programme. [REDACTED] [REDACTED] are supporting nursing colleagues by assisting with resident care under supervision , assisting residents at mealtimes, communicating and updating all family members re residents health status ,assisting with visits and communication via skype when residents are at end of life. We are in contact with Public Health on a daily basis and following Infection control advice. We have a fulltime IPC lead nurse on site. We are also supported daily by DON, Hospital manager, General Manager and the HoSC. If you require any further information either [REDACTED] or myself are here every day.
