1.0 Quorum

The Chairperson welcomed Board members to the meeting. A quorum was present and the meeting was duly convened.

3.0 Emerging Issues and Risks

4.0 CHI Review

Sean Egan (SE), Director of Healthcare Regulation introduced the item and advised that he was joined by members of the review team Rosarie Lynch (RL), Head of Programme Healthcare, Gillian Hastings (GH), Statutory Investigations Co-ordinator and Rosie O'Neill (RON), Healthcare Inspector.

SE gave the presentation which provided assurance to the Board on compliance with the Quality Assurance Framework (QAF) in the conduct of the CHI section 8 review. He highlighted the following:

- The Board had approved the Quality Assurance Framework for the Section 8 CHI Review on 31 October 2023.
- The QAF facilitates a rigorous governance structure and approach for undertaking section 8 reviews and section 9 statutory investigations.
- Implementation of the QAF uses a project management approach and serves as a guidance and quality assurance mechanism in carrying out the review or investigation.
- Detail was provided on how each of the Key Quality Indicators of the QAF were complied with in the conduct of the review.

The Board congratulated the review team in relation to the completion of this review and noted the rigour applied in the conduct of the review which was extensive and thorough.

AF acknowledged the leadership of SE on this issue and also acknowledged AMC and the legal team who provided extensive legal support.

PK proposed the approval of the presentation which provided confirmation that the Section 8 CHI review had been carried out in line with the Board approved QAF and CFN seconded the proposal; **accordingly, it was unanimously resolved that the presentation which provided confirmation that the Section 8 CHI**
